1. Validity Period

- Gift Cards are valid for **one (1) year** from the date of purchase unless otherwise stated on the card or receipt.
- After the expiration date, any remaining balance is forfeited and cannot be reinstated.

2. Redemption

- Gift Cards may be redeemed **only at Showalter Home & Forge** for eligible products or services.
- Gift Cards **cannot be redeemed for cash**, except where required by law.
- Gift Cards cannot be used to purchase additional gift cards.

3. Balance & Usage

- Merchandise purchased with a Gift Card may be refunded according to our standard return policy, and refunds will be issued back to the Gift Card or in the form of store credit.

- We reserve the right to update or modify these Terms at any time without prior notice.
- The terms in effect at the time of purchase will apply to that Gift Card.

8. Limitation of Liability

- To the fullest extent permitted by law, Showalter Home & Forge is not liable for:
 - Unauthorized use of a Gift Card
 - Lost or stolen cards
 - Failure to use a Gift Card before expiration
- Our maximum liability is limited to the unused balance of the Gift Card.
